

Students Riding in Private Transportation

APPLICATION FOR PERMIT TO DRIVE MOTOR VEHICLE TO SCHOOL

RULES AND REGULATIONS

1. I shall comply with Ohio State laws in reference to being properly licensed.
2. I shall enter the school grounds by the entrance driveways only, located on Route 81.
3. I shall park my vehicle in the student parking lot upon entering the school grounds, and will not enter or move the vehicle during the day without permission from the office, and will stay away from all other parked cars.
4. I shall not haul other pupils from the school grounds at dismissal time unless a written request by the parent or guardian of the pupil requesting a ride is given to the Principal by 8:15 A.M. on the day the request is desired and the student shows me his office pass.
5. I shall comply with the speed limit on the school grounds, which is 10 miles per hour, and shall comply with Ohio State Laws in regards to passing a bus which stops to load or unload passengers.
6. I shall return this permit to the principal's office and register with him.
7. I understand that the vehicle driver is TOTALLY responsible.

I further agree that failure to comply with the above rules and regulations at all times may nullify my privilege to drive a motor vehicle on the school grounds and may cause me to be suspended from school.
